

**Questions and Answers for Request for Proposals (RFP) 2008-03
Foreclosure Prevention Counseling Training and/or Technical Assistance Services**

Question 1:

Are non-profits eligible for funding under this RFP?

Answer:

Yes.

Question 2:

How much funding is available for the training component and the technical assistance component?

Answer:

Florida Housing Finance Corporation (Florida Housing) has not established any specific amount for the services requested.

Question 3:

How many individuals do you expect to attend the training?

Answer:

Florida Housing expects Offerors to propose the number of participants they can accommodate for each training session in their training plan as requested in Section Six, paragraph E.1 of the RFP.

Question 4:

The RFP states that trainings will be conducted for at least 3 different regions. Does this mean we should budget for only three to five day sessions lasting 6 hours per day?

Answer:

Florida Housing currently envisions providing three (3) training sessions over the coming year. If Florida Housing determines that additional training sessions are needed, Florida Housing will negotiate with the Contractor to provide additional training sessions.

Question 5:

What type of volume do you anticipate for the telephone and email technical assistance?
